

# 2025 Master Agreement

Lima Crossroads Council, Inc.

This Master Agreement is entered into by and between Lima Crossroads Council, Inc. dba Lima Fest (hereinafter referred to as "The Organization"), and \_\_\_\_\_ (hereinafter referred to as "The Party"), collectively referred to as "The Parties."

## 1. Event Details

- Event Name: Lima Fest

## 2. Purpose of Agreement

This agreement outlines the terms and conditions governing the participation of The Parties in the Lima Fest event. It refers to specific sub-agreements regarding individual responsibilities and specifications.

## 3. Roles and Responsibilities

- The Organization is responsible for the overall management and promotion of Lima Fest.

## 6. Insurance

The Party is required to obtain and maintain adequate insurance coverage for their participation in the event, including but not limited to general liability insurance. The Organization shall be named as an additional insured.

## 7. Term and Termination

This agreement shall commence upon signing and terminate on August 4, 2025, unless otherwise stated in a sub-agreement. The Organization reserves the right to terminate the agreement for breach of terms.

This Agreement shall be governed by and construed in accordance with the laws of New York State, USA, without regard to its conflict of law principles.

## 9. Amendments

Amendments to this Agreement must be made in writing and signed by both parties.

This Master Agreement, along with sub-agreements, constitutes the entire agreement between the parties and supersedes any prior or contemporaneous agreements, whether written or oral.
